15 Description of Product

The Moflash IS-B-02-xxxx beacon is an intrinsically safe 'ia' equipment designed to give a visual warning signal when activated. The equipment contains one main PCB that has LEDs to provide visual warning and a control circuit.

The power is supplied by IECEx/ATEX approved barriers only. The enclosure is completely non-metallic and has an IP66 rating. The enclosure can be of various colours such as red, amber, white or clear. The units are fixed installations.

The optical radiation output of the apparatus with respect to explosion protection is covered in this certificate based on Exception 1 to the scope of EN 60079-28:2015.
